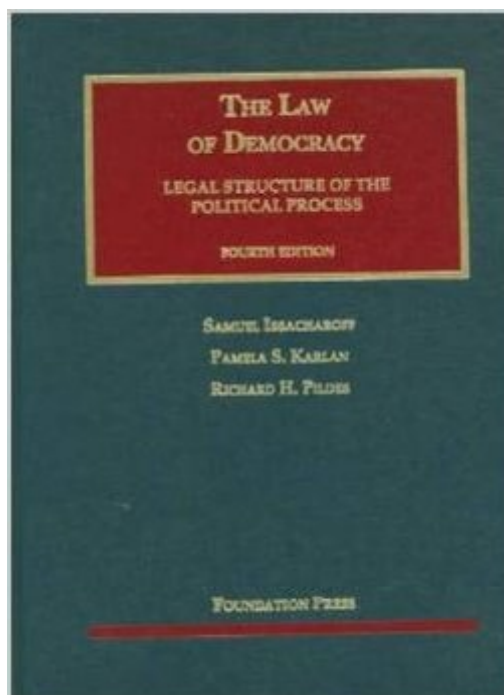

## Synopsis

Much of this edition's revision consists of making note material more concise and reducing the coverage of issues that have become less important as the frontiers of the field moved in new directions.
